**AMENDED RESOLUTION 21-03**

**A RESOLUTION OF THE CITY OF AMBLER COUNCIL TO HUNKER DOWN THE COMMUNITY OF AMBLER, AK FOR THE HEALTH AND SAFETY OF OUR PEOPLE, TO PREVENT THE INTRODUCTION OR SPREAD OF THE COVID-19 WITHIN OUR COMMUNITY**

- WHEREAS** The City of Ambler is a recognized second-class city; and
- WHEREAS** The City of Ambler council are elected officials authorized to act on behalf of the Citizens of Ambler, being mindful of the responsibilities for the welfare of our community and in order to provide local government service to our people to meet their needs, do establish resolutions and ordinance for the City of Ambler; and
- WHEREAS** The City of Ambler council is locking down the community of Ambler, AK for the health and safety of our people, to prevent the introduction or spread of the COVID-19 within our community; and
- WHEREAS** The City of Ambler council prohibits ALL incoming passenger travel leisurely by air, land or water into the community of Ambler, Alaska; and
- WHEREAS** The City of Ambler Council is requesting all passenger airlines to stop all unauthorized incoming passenger travel into the community of Ambler, AK; to prevent the introduction or spread of the COVID-19 within our community; until September 10,2020 There will be no unauthorized passenger travel by air, land and water allowed within Ambler City limits until September 10, 2020; and
- WHEREAS** The City of Ambler accepts incoming and outgoing medical authorized travel, individual returning must quarantine for fourteen (14) days; and
- WHEREAS** The City of Ambler accepts authorized essential worker with proof of negative COVID-19 test, only for emergency services. Authorized essential workers who traveled under personnel medical reasons are required to quarantine for fourteen (14) days, and follow the city mandates; and
- WHEREAS** The City of Ambler Council mandate a COVID-19 negative test verification form in order to return to the community of Ambler, AK; and
- WHEREAS** The City of Ambler Council mandate all essential and medical incoming travel, to quarantine themselves and their entire household for fourteen (14) days; and are required to post a quarantine verified notice on entrance of house; and

**WHEREAS** The City of Ambler Resolution 21-03 shall remain in effect until 5:00 P.M. on Thursday, September 10, 2020, and will continue to be in effect if the Coronavirus (COVID-19) continue to arise in the NANA Region until a new or amended resolution is in place; and;


**WHEREAS** The City of Ambler will fine unauthorized travelers; 1<sup>st</sup> offense \$250, All subsequent violations \$500; as stated in City of Ambler Ordinance 20-01; Ordinance Section 5.01.050


