PUBLIC NOTICE

09/28/2020

In order to prevent and make the necessary precautions amidst the latest developments with COVID-19, the governing bodies have made the decision to take these steps:

- 1. Travel Advisory: travel to and from the village is restricted to medical travel only. Travel is permitted for cancer patients and/or serious medical issues; all other travel is prohibited from today until October 21,2020. All individuals are not allowed to travel in or out of the village during this time unless in a medical emergency. All residents traveling from Anchorage to our community will be asked to mandatorily take the rapid test that Is offered before their arrival. This travel advisory will be in effect immediately and maybe subject to extension. Must show a negative test result after returning on the 10th day after returning to be released from quarantine. People who take day trips must also take a test on the 10th day upon return.
- 2. ALL travelers must get authorization prior to coming in or leaving the village, from the Mayor and/or the Tribal Administrator.
- 3. Masks MUST be worn at all times when in public areas by ALL. Public areas include: School, Stores, Clinic, Tribal and City offices, and the Post office.) Once inside social distancing guidelines must be followed.
- 4. The City and Tribal Offices will remain closed to the public and ask that the public call in to make an appointment in advance for assistance.
- 5. The Fuel Project and Rotmans Stores will also take the necessary precautions; staff personal hygiene is mandated to protect both staff and customers.
- 6. As a part of the advisory, we encourage households to limit visitors, homes that have Elders and those with health issues are at the greatest risk.
- 7. Effective as today the curfew for all residents in the community to remain at 10pm until further notice.
- 8. All individuals including the household individuals will require remaining in quarantine up to 7 days to be evaluated for symptoms that may arise during this time when returning home. If residents are not following the mandate of quarantining, there may be fines that are associated with these steps.

1st Infraction-\$ 250.00

2nd Infraction-\$300.00

3rd Infraction- \$ 500.00

- 9. All residents coming into the community must show proof that they currently reside within the community / village prior to arrival, this may force a decision to be made that will be denied request to return to the village if they are not a required essential worker listed below:
 - (Health aides, law enforcement officers, water and sewer workers, postal workers, city and tribal office workers, telecommunication, AVEC workers, Store Workers, Flight agents, School staff, custodians) or any other stated individuals that are being approved to enter into the community. Inter- Village travel is strictly prohibited by boat or plane.
- 10. All individuals arriving to the community must get approval from Tribal Office before their arrival. We want to keep our community COVID free and we need to work together to make this possible.

We are looking out for the health and safety, well being of our community. We would like to be proactive, rather than reactive and make sure we make this mandate be used as a tool to prevent the spread of the virus. Any questions are concerns you have, please feel free to contact the City or Tribal Office Administrators at their respective offices. We can work together and be responsible to address the need of actions taken as necessary steps to help prevent the spread of the virus.
