## **RESOLUTION #21-03**

## A RESOLUTION OF THE CITY OF NOORVIK COUNCIL FOR THE COMMUNITY OF NOORVIK'S LOCAL EMERGENCY PROCLAMATION DELCARATION IN RESPONSE TO THE RAPID SPREADING COVID-19 VIRUS.

WHEREAS: The City of Noorvik is the Municipal Governing Body of Noorvik, Alaska; and

**WHEREAS**: We continue to exercise and promote the precautionary measures for our residents and community members, which is the number one priority by local leadership for the health and safety with the fast spreading COVID-19 Virus considering the increase of positive cases within Alaska and the NW Region; and

**WHEREAS**: The City office is closed to the public until further notice; and the City Council has instituted a student curfew set at 8:00 pm to 8:00 am and 10:00 pm to 6 am for adults and/or residents 18 years and older; for the safety of our residents, children and elders; and

**WHEREAS**: Travel is restricted to Noorvik by any non-residents and outsiders in agreement and instruction from the regional organizations on the COVID19 Virus Task Force so that the health and safety to our people is not jeopardized; and

**WHEREAS**: Anyone wishing to travel into Noorvik is required to get COVID-19 Virus testing 72 hours prior to departing on any airline and/or any means of transportation; as well as travel authorization from the tribal office and COVID-19 Coordinator; and

**WHEREAS**: The City of Noorvik, Alaska wishes to restrict all inter-village travel by aircraft, water, land, for the health and safety of our community and surrounding villages; and

**WHEREAS**: All public gatherings are limited to no more than 10 persons, 6 feet social distancing be observed, and that Mask wearing is used; and

**WHEREAS**: Residents and community members returning from outside the Community of Noorvik are asked to quarantine and/or isolate themselves at home for two full weeks (14 days), and observe social distancing, mask using for the health and safety of the community; and

**WHEREAS**: Residents whom are also known as "essential" workers are required to get COVID-19 tests prior to arriving back in the community and must quarantine and/or isolate themselves at home for two full weeks (14) days and observe social distancing; and

## **Continuation of Resolution #21-03**

**WHEREAS:** All households in a full two weeks (14) day quarantine and/or isolation are recommended to use the services for phone orders and deliveries provided by the Noorvik Native Store.

WHEREAS: No child and/or children under the age of 18 shouldn't not be in any public places and/or streets and that parents or guardians are to instruct their children of this directive; and

**WHEREAS**: The selling of prepared food within the community and/or on the VHF radio is prohibited; and

**NOW THEREFORE IT BE RESOLVED**: The City of Noorvik, would like to declare the Coronavirus a deadly threat to our community and health and safety of our residents.

**FURTHERMORE**: This proclamation will be in effect November 30, 2020 starting at 8:00 PM and will remain in effect until December 30, 2020 at 6AM and may be extended after that date.
